The UI for Xamarin License Giveaway @ Build 2017 Official Rules

NO PURCHASE NECESSARY TO WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. ELIGIBILITY. The Progress Software Corporation ("Progress") UI for Xamarin License Giveaway @ Build 2017 (the "Contest") is a contest offered solely to those attendees of the Build 2017 Conference ("Conference"), who are eighteen (18) years of age or older and the age of legal majority in his or her state or jurisdiction of primary residence at the time of entry ("Participant"). The Contest is void in Rhode Island and where prohibited or restricted by law. The Contest is subject to all applicable federal, state, provincial and local laws. Employees of Progress, and any of their related companies, subsidiaries, affiliates and agents and any agencies or other companies involved in the development or execution of the Conference or Contest or production or distribution of Conference or Contest materials, as well as the immediate family (spouse, parents, siblings, and children) and household members of each employee are not eligible. - TIMING. The Contest begins at 8:00 am EST on May 3, 2017 and ends at 5:00 pm EST on May 12, 2017 (the "Contest Period"). All Entries (defined below) must be received by 5:00 pm EST on May 12, 2017. Progress is the official time-keeper for the Contest.
- 3. HOW TO ENTER. To enter the Contest, Participants must publish posts and/or photos in response to the questions "Why do you want UI for Xamarin?" with the hashtag #TelerikUIforXamarin, on the Participant's Twitter page ("Entry"). No more than one (1) Entry on Twitter per Participant during the Contest Period will be considered. Any Entries over this maximum during the Contest Period will not be considered. The Contest is in no way sponsored, endorsed or administered by, or associated with Twitter. Each Participant hereby releases Twitter of any and all liability of any kind.
- 4. CONDITIONS OF ENTRY. Any incomplete, inaccurate or false Entries will be excluded. The Entry must meet each of the following requirements:
  - a. The Entry must be owned and created by the Participant;
  - b. The Entry may not contain any improper use of trademarks, logos, or copyrighted elements. Any content that appears in the Entry must be entirely original, created and performed solely by Participant, or be in the public domain; and
  - c. - 5. ODDS OF WINNING. The odds of winning will be determined by the number of eligible Entries received.
- 6. WINNER SELECTION AND NOTIFICATION. One hundred (100) winners will be randomly selected from the eligible Entries received during the Contest Period, subject to the applicable Twitter rules and policies. The drawings will be held no later than 5:00 pm May 19, 2017 and the winners contacted by direct message or email.
- 7. PUBLICITY. Except where prohibited by law, by participating in this Contest, each Participant (i) agrees to be bound by these Official Rules and (ii) grants to Progress and its affiliated/subsidiary companies the
